1. The camp dates are **July 7-12**. The staff team will be meeting out at the camp **early Sunday morning (9am)** for training as well camp prep and preparing spiritually to lead kids into a deeper relationship with Christ.
2. This is no small commitment. Even though there will be designated rest time for volunteers each day, you will be exhausted and expected to make the best decisions at all times, even when frustrated.
3. We are there to minister to the kids. This is not a holiday, and we need to be prepared spiritually and practically for the ministry. Don't be surprised if your own spiritual life is changed throughout this experience.
4. The camp itself will be of no cost to you. It is free.
5. By the time the camp starts a criminal record check is required as part of Plan to Protect, which all staff team members are required to submit to attend.

Personal Covenant and Liability Release Form

The guidelines listed below are recommended for those participating in this journey. It is very important to be flexible and willing to adjust to the expectations of your host.

I recognize and accept the following conditions which will further the usefulness and safety of our camp, staff, and campers. If accepted as a member of this team, I agree to:

- 1 Release and discharge the organizations and individuals which helped make these arrangements including Chubb Lake Bible Camp, their agents, employees, officers, and volunteers, from all claims, demands, actions, judgments, or executions that I have ever had, or now have, or may have, or which my heirs, executors, administrators, or assigns may have or claim to have against these organizations, their agents, employees, officers, and volunteers, and their successors or assigns, for all personal injuries, known or unknown, and injuries to property, real or personal, caused by or arising, out of this journey. I intend to be legally bound by this statement.
- 2 Adopt an attitude that I am on this team to attempt to serve the camp, its staff, and its kids. I go knowing that there are many different ways to accomplish the same objective, and recognize that my way is not necessarily the best way.
- 3 Abstain from making derogatory comments or arguments regarding people, politics, sports, religion, race, or traditions.
- 4 Go as a servant-disciple of Jesus Christ and will adopt that Attitude when dealing with my fellow team members and the people I meet during the camp.
- 5 Accept and submit to the leadership role and authority of the camp directorship and promise to abide by his or her decisions as they concern this camp.
- 6 Acknowledge that by engaging in this journey, I am subjecting myself to certain risks voluntarily, including and in addition to those risks that I normally face in my personal and business life, including but not limited to such things as health hazards due to camp living conditions.
- 7 Understand that our team's work is but a tiny speck on the bigger picture that our area is trying to accomplish. I promise not to be overly demanding, to do my best not to offend or cause embarrassment for the camp and/or its attendees, and to do my best to help them attain their long-term goals.
- 8 Refrain from meddling, complaining, and obscene or insensitive humor. I realize that the minors and others on the volunteer team will look at me for an example of how a Christian acts, and will not treat that responsibility lightly.
- 9 Regarding the differing styles of worshiping with respect. I promise that where I see the need, I will witness my faith, but without a superior, colonial attitude.

- 10 If a loved one or dear friend is also present at the camp, we agree to interact with all volunteers, not just one another. I promise not to initiate or seek new romantic relationships with team members during the camp.
- 11 Avoid any actions, which might be perceived as amorous attentions toward any of the people I meet.
- 12 Refrain from using tobacco or alcoholic beverages during camp. Abstain from any illegal drugs or prohibited activity while serving at the camp.
- 13 Remember that we are the Christians the kids will look up to for years to come, and will be watched very closely. I will not take lightly this important responsibility of setting an example.
- 14 If I feel compelled to give a gift to someone I have met, I will consult first with the camp director before I promise or give the gift, and I promise to let him or her make the final decision on this matter. This covenant does not apply to small tokens and rewards for the kids.
- 15 Act as a servant-disciple of the camp leadership. I will respect the advice I am given concerning attire, behavior, and other things that may cause another to look down on your role as a leader.
- 16 Understand that every member of this group is expected to share freely from their particular blessings and talents, whether that is skills such as music, art, acting, dance, or basic hard work. I agree to participate in these ways as fully as possible.
- 17 I agree that in event my conduct is considered so unsatisfactory that it jeopardizes the success of the camp, and that mediation during the camp has failed to correct my behavior, that my services in connection with this camp shall end and I shall return home immediately at my own expense.
- 18 In signing below, I represent that I am 19 years of age or older, or my parent/guardian will sign also, accepting the above conditions on my behalf.
